關注吸食電子煙及太空油毒品問題
校方相應措施

敬啟者：

近日本港媒體廣泛報導吸食電子煙及太空油毒品有年輕化趨勢，為保護學童，防範於未然，學校已透過早會、周會、展板及播放影片，向同學灌輸有關知識，藉此加強向師生宣傳吸食電子煙及太空油毒品的禍害。

校方已於上星期向 貴家長發出通函，提醒家長務必多留意子女的情緒變化、作息時間及社交圈子，多與孩子討論毒品與電子煙的禍害，強調健康生活的重要性。一旦發現子女行為有異或持有來源不明的物品(如電子煙設備)，請提高警覺，有需要時立刻與校方聯絡。

為加強保障，防止吸食太空油的行為入侵校園，如校方接獲投訴或舉報指學生涉及電子煙或太空油毒品的情況時，學校將按照教育局《學校行政手冊》3.7.2 段「處理涉及毒品事件的措施」，及時聯絡家長，並按教育局及校本機制通報有關人士，讓學生得到適當的輔導及跟進。


為保障學生的健康和維持校園紀律，請各位家長知悉及贊成在合理及切合需要的情況下，校方將根據教育局《學校行政手冊》3.6.4 段，在合法、無不合理的情況下，按照「搜查學生財物的原則及程序」和私隱專員公署相關指引，以尊重的方式，組織「不定時」的巡查行動，檢視學生有否攜帶違反校規的物品回校。如在巡查期間發現違規物品，會即時聯絡家長及按相關指引跟進。

請於四月二十九日(星期二)或之前簽妥電子通告回條，以便統籌辦理。如家長對以上有任何疑問，歡迎致電 2443 9899 與訓導主任蔡燕芳老師或吳志騰老師聯絡。

Dear Parents

Recently, local media has widely reported a trend of younger individuals using e-cigarettes and “Space Oil Drug”. To protect students and prevent them from the potential harm, our school has been educating students about the dangers of these substances through morning assemblies, seminar, display board and video presentations.


As addressed in our eNotice last week, we urge parents to pay close attention to your child’s emotional changes, daily routines, and social circles, and encourage them to share their school life with you. Please take the opportunity to discuss the dangers of drugs and e-cigarettes with your child, emphasizing the value of a healthy lifestyle. If you find your child any unusual behaviours or in possession of items of unknown sources, such as e-cigarette devices, please remain vigilant and contact the school immediately.

To prevent the infiltration of Space Oil Drug abuse on campus, if the school receives complaints or reports regarding students involving with such substances, we will follow **the instructions of the Education Bureau’s School Administration Guide (Section 3.7.2: Measures for Handling Drug-Related Incidents)**. This includes promptly notifying parents and reporting to relevant authorities to ensure students receive appropriate counselling and follow-up support under the EDB and school-based policies.

To ensure students’ health and maintain school discipline, **we sincerely ask all parents to be notified and support the school’s reasonable and necessary measures**. The school may carry out “random inspections” in accordance with the **Section 3.6.4 of the EDB’s School Administration Guide and the Privacy Commissioner’s guidelines**. These inspections will be carried out lawfully, respectfully, and without undue intrusion, following the **Principles and Procedures for Searching Students’ Belongings**. If any illegal substances are found during such inspections, we will immediately contact the parents and follow the above guidelines for further actions.
