

A student briefing session will be held on **8th July 2025 (Tuesday) from 12:00 nn to 1:00pm** in the school hall. iPads will also be distributed to students who purchased it through the school or successfully applied for the Education Bureau's " Quality Education Fund e-Learning Funding Programme—Provision of Mobile Computer Devices and Internet Services Support " (Mobile Device Rental Scheme).
